- Contestants must attend a Stoddard County School District. If the contestant is not school age or is home schooled they must reside within Stoddard County.
- Contestants must enter the appropriate age division, according to their age the day of the pageant. **NO EXCEPTIONS!**
- Contestants shall be single, shall never have been married, nor had a marriage annulled, nor have cohabited with a male in lieu of a marriage contract. (Miss Division)

# Stoddard County Fair Eighth Annual Amateur Photography Contest 2018

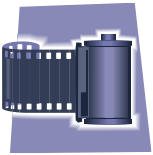

Rules are as follows:

- You are allowed one entry. They are to be brought to the Dexter Chamber of Commerce, Inc. located at 515B West Market by September 7th. (For information call Janet Coleman at 573-624-0421.)
- Entry must be an 8x10 photograph and matted into a mat suitable for framing. Can be color or black and white photograph.
- Entries must be photographed in Stoddard County from September 2017 through August of 2018
- On the back of your entry on an index card you must list the following.
  - Your name and address.
  - Your telephone number.
  - Your Age (OPEN 6 yrs. And Up)
  - Who, What, When and Where.
  - What type of camera you used.
  - Must provide a three worded title caption or description of photo.



**Prizes will be awarded to the “TOP THREE PHOTOS ONLY”.**

All entries will be displayed during Fair Week at the Fairgrounds and after the fair at the Dexter Welcome Center through October 31, 2018. All photos displayed at the Welcome Center will be available to be picked up after October 31<sup>st</sup> at the Dexter Chamber of Commerce.

# STODDARD COUNTY FAIR DIVISION RULES

CLASSES – Open, 4-H, FCCLA

## ATTENTION

**All 4-H categories have been included in the general listing of categories.**

**All exhibitors (4-H, FCCLA, OPEN) may enter only four (4) exhibits per entry number.**

1. All exhibits must have been made since the 2017 County Fair and never exhibited in the Stoddard County Fair.
2. Persons may enter only four (4) exhibits per entry number and exhibits must be entered in the name of the person who made the item.
3. The Fair Book Committee reserves the right to reject any entry.
4. All youth exhibitors must show age on entry tag.
5. **EXHIBIT TAGS MUST BE COMPLETED IN FULL TO RECEIVE PREMIUM MONIES.**
6. Open classes are open to the State of Missouri.
7. Fair Board will not be responsible for any damaged, lost or stolen items.

## RULES AND REGULATIONS FOR FOODS

1. Standard colorless canning jars with standard lids. (No mayonnaise, peanut butter, etc. jars).
2. No artificial coloring.
3. All jars must be sealed and processed. The process method should be included on the jar.
4. Bands should be left on jars when using two (2) pieces.
5. Limit of 20 per person.
6. Baked goods should be wrapped in clear plastic bags and displayed on paper plates. Recipes must be attached.

## **CLOVER KID PROGRAM**

1. No wildlife allowed
2. All animals must be caged, leashed and/or contained as appropriate and manageable by the child during 4-H Clover Kids meetings and events.
3. Parent or guardian must be present with his or her child(ren) when animals are involved.
4. Clover Kid exhibits are not judged and will receive a green ribbon at the Fair.
5. National, State and County Approved Small Animals for Clover Kids to exhibit are: Amphibians (toads, frogs); Birds; Cavies (guinea pigs, gerbils, hamsters); Cats; Chinchillas; Dogs; Fish; Hedgehogs; Lizards; Mice; Rabbits; Rats; Snakes.
6. Clover Kid members may only exhibit animals approved in the publicized list in the 4-H Clover. Clover Kid members MAY NOT exhibit or Sell in LARGE livestock category.

## LIVESTOCK DIVISION

### GENERAL RULES AND REGULATIONS

#### ALL ANIMALS MUST HAVE HEALTH CERTIFICATE AND ALL MARKET ANIMALS WILL BE WEIGHED WHEN UNLOADED.

1. Each animal & poultry shown at the fair must be preregistered by September 1, 2018. Registration forms are to be mailed to Angie Parks, PO Box 187, Bloomfield, MO 63825, Email: [angieparks39@gmail.com](mailto:angieparks39@gmail.com). Within two weeks after this date the Livestock Chairman and Livestock Co-Chairman reserve the right to meet with all exhibitors of market animals to see and tag the animal if necessary. If animals are not preregistered, they will not be eligible to show or sell at the fair this year. **THERE WILL BE NO EXCEPTIONS.**
2. 4H/FFA classes are open to 4H & FFA Chapter members who live in Stoddard County and/or a member of a Stoddard County 4H or FFA Chapter. Members entering livestock must be paid up active members in their chapters or clubs in order to be eligible to show, sale or receive premiums. Active, paid-up status will be verified (in case of question) with the FFA or 4H Advisors.
3. Any question of sickness in exhibited livestock will be resolved by inspection by a DVM. Sick animals will be removed upon the recommendations of the veterinarian.
4. Entries will be accepted on Monday, Sep. 17<sup>th</sup> for large animals (Noon – 7 PM) and small animals (4 PM – 7 PM) of the Fair Week. There will be a small animal show during check-in at the 2018 Stoddard County Fair. This includes all rabbits, cavies and poultry with the exception of geese and turkeys. Each exhibitor must remove the animal from the cage and place it on a table for judging without help from anyone else. The animal will not be exhibited at the fair if the exhibitor is unable to do this.
5. Livestock can be checked out between the hours of 8 a.m. through 1 p.m. on Sunday, September 23, 2018.
6. Each exhibitor must show their own animal in each class unless they have more than one animal in the same class; then, they may choose someone to exhibit the extra animal for them.
7. All judging will be done by the Danish system, which includes blue, red, and white ribbon groups. Each animal will be judged on its own merit. All ribbons will be awarded at the judge's discretion. The decision of the judges is final.
8. Exhibitors are limited to two entries per class number, with the exception of market animals.
9. Exhibitors in market classes will be limited to showing and selling not more than 2 market steers, 2 market hogs, 2 market lambs, and 2 market goats.
10. **“No Market Animals can be shown as breeding stock.”**
11. The decision of the judge will be final and irrevocable in regard to premiums awarded. In any show where there is only one entry, the judge reserves the right to award less than first premium, if entry does not warrant the same.
12. A quorum of the livestock committee may reserve the right to discontinue any livestock activity in the event of bad weather or other unavoidable causes.
13. The time between shows will be held to ten (10) minutes after the previous

- show, NO EXCEPTIONS.
14. Only the Judge, Livestock Chairman, Livestock Co-Chairman, designated individuals and Exhibitor may be in the ring during show.
  15. No responsibility will be taken in case of fire, theft, damage, injury, or death of any person, animal or article.
  16. Each livestock exhibitor is responsible for the feeding and watering daily of their livestock and for furnishing the bedding, feed, water, water bucket, and feed bucket. (PLACE USED BEDDING AT EAST END OF SOUTH LIVESTOCK BUILDING.)
  17. Only exhibitors will be allowed to stay and care for livestock.
  18. Entries must, in all cases, be made in the clerks books and entry ticket promptly attached before animals will be permitted to compete for premiums.
  19. Leaders of FFA and 4H will be responsible for the conduct of their members. Misconduct means withdrawal of exhibits. Parents will assume the responsibility for youth ages 7 and under. In accordance with the state 4H Office, youth enrolled as 4H Clover Kids will not be eligible to show or sell in any livestock category.
  20. Open class entries are open to the state.
  21. Entry tag must be in on Monday, September 17<sup>th</sup> by 7 pm to committee Chairman. **ALL LIVESTOCK EXHIBIT TAGS MUST HAVE CLASS NUMBER & BREED LISTED.**  
**EXAMPLE: 617 Black Angus**
  22. Point schedule is the same for Open, 4H and FFA.
  23. Exhibitor must be present for animal to show.
  24. Animals below minimum weight requirements can show, but not sell at auction.
  25. Coggins papers required on all equine.



## **4H & FFA LIVESTOCK SALE GUIDELINES**

1. The 4H & FFA Sale is sponsored by the Stoddard County Fair Board.
2. Sale is open to 4H & FFA exhibitors ONLY.
3. All animals will sell by head in dollars per pounds.
4. Buyer has first option of keeping animal purchased in auction. If buyer does not keep animal, ownership stays with seller.
5. Sell order will be based on placing in show.
6. The Stoddard County Fair Board will collect the payment from the buyer and distribute checks as soon as all money is collected.
7. All entries subject to approval of the Stoddard County Fair Board.
8. Livestock will sell by local market guidelines.
9. **Exhibitors must be present at Livestock Auction for livestock to show and sell.**
10. There will be NO CHARITY AUCTION at the end of the sale
11. After 4H & FFA sale, seller of all market animals will be responsible for hauling animals to market as specified by the buyer.
12. A market animal can be shown and sold at another fair and still be qualified to be shown and sold at the Stoddard County Fair, PROVIDING that it was not a terminal sale and meets ownership requirements.
13. Animals below minimum weight requirements can show, but not sell at auction.

## **4H/FFA/OPEN PUBLIC SPEAKING CONTEST**

Saturday, September 22, 2018 – Time 2 PM

Stoddard County Fairgrounds - Dexter, Missouri

The Stoddard County Fair Public speaking Contest is designed to develop agricultural leadership, provides for member participation in agricultural public speaking activities, and stimulates interest in leadership and citizenship. The final contest for the Sr. Division will be held in connection with the Missouri Association of Fairs and Festivals (MAFF) Annual Convention, scheduled at the Holiday Inn Executive Center, Columbia, MO.

### **I. GENERAL PLAN**

All preliminary contests are for local participation and are held under the direction of the county fair concerned. These events finalize in the state contest held at the MAFF annual convention. All county contests must follow same rules as the MAFF Public Speaking Contest finals.

### **II. ELIGIBILITY**

1. The state contest will be limited to participation by any 4-H/FFA/Open member, grades 9 through 12 during the current school year. Previous state winners (first place, second place, or third place) will not be eligible to compete again.
2. Each contestant's manuscript will be the result of the student's OWN EFFORTS. It is expected that each contestant will take advantage of all available training facilities in their local area in developing their speaking ability. Facts and working data may be secured from any source BUT MUST BE RELATED TO FAIRS AND AGRICULTURE. Topics of a non-agriculture nature will be disqualified.
3. **Contestants who compete must submit to the Fair Board Secretary the following materials:**
  - a. Four double-spaced typewritten copies of their speech on 8 1/2 x 11 paper each copy bound by a staple.
  - b. A complete and accurate bibliography used in writing the speech.
  - c. A signed copy of the originality form as provided.
  - d. All contestants in the MAFF Public Speaking Contest shall give credit to others where any direct quotes, phrases, or special dates are used in their manuscript in order to not be guilty of plagiarism. Failure to do so will automatically disqualify a contestant.

**The above materials MUST BE DELIVERED TO THE FAIR BOARD SECRETARY AT THE FAIR GROUNDS ON Sunday, September 16, 2018 between 1 PM and 4 PM.**

### **III. TIME LIMIT**

Each speech shall be a minimum of six (6) minutes in length and a maximum of eight (8) minutes. Each contestant will be allowed five (5) additional minutes in which judges will ask questions relating to their presentation. Deductions of 1 point per second will be made from the score of each judge for speeches under six minutes or over eight minutes.

#### IV. METHOD OF SELECTING WINNER

1. Three competent and impartial judges will be selected to judge the contest. Prior to the contest each judge will be provided a copy of each manuscript which they will read and score on content and composition on the score sheet provided.
2. Contestants will draw for position. The contest chairman will introduce each contestant by name and number. Applause shall be withheld until all contestants have spoken.
3. One time keeper will be assigned to record time used by each contestant noting underage or overage for which deductions should be made.
4. At the time of the contest each judge will score each contestant on their delivery using score sheet provided. A contestant may use notes during their presentation however deductions may be made for this practice if it distracts from the effectiveness of the delivery.
5. Judges shall formulate and ask questions that pertain directly to each contestant's subject. Judges will score each contestant based in their ability to answer ALL questions ask by ALL judges. The full five minutes will be used.
6. Contestants will be ranked in numerical order based on final score as determined by the judges. Finalists will be selected whose scores ranked highest by each judge. Additional winners are selected using same basis (highest total points on scorecard method). Judges will then rank contestants as 1, 2, 3 with highest total declared winner. In the case of a tie, at the contestant who has the highest grand total score shall have prior rating.
7. When contestants have finished speaking each judge will total their score on composition and delivery. The time keepers record will be used in completing the final score.

#### V. Representation

The winner of the senior division shall be eligible to give their speech at the Missouri Association of Fairs and Festivals (MAFF) held in Columbia, Missouri. If an entrant has already won a MAFF contest he/she may present their speech as practice & not for judging. Contestants must notify the Fair Board Secretary, Dawn Miller (573-421-4842) your intention to attend the State MAFF Contest by November 1<sup>st</sup> of the Current Fair Year.

FFA: 1st Place - \$100.00 & Plaque; 2nd Place - \$ 50.00; 3rd Place ----- \$ 25.00

4-H: 1st Place - \$100.00 & Plaque; 2nd Place - \$ 50.00; 3rd Place ----- \$ 25.00

OPEN: 1st Place - \$100.00 & Plaque; 2nd Place - \$ 50.00; 3rd Place ----- \$ 25.00

## VII. Travel Expenses

As part of their participation in the MAFF a motel room will be reserved for the contestant. Said person shall notify the Fair Board Secretary, Dawn Miller (5673-421-4842) of their decision not to attend at least 72 hours prior to the date they are to be present for the MAFF contest or they and their family will be responsible for the room costs and any additional charges assessed. An additional \$200 shall be given to said person upon proof of their attendance and participation in the MAFF contest.

No gas/food expense will be furnished by the Missouri Association of Fairs and Festivals.

## **JUNIOR PUBLIC SPEAKING CONTEST**

The contest will be limited to participation by any Junior 4H/FFA/OPEN (ages 8 to 13), during the current school year, either boy or girl.

**ALL RULES ARE THE SAME EXCEPT FOR THE LIMIT ON THE SPEECH, WHICH IS MINIMUM OF 3 MINUTES AND MAXIMUM OF 5 MINUTES AND THEY DO NOT COMPETE AT THE MAFF ANNUAL BANQUET.**

Since the mid-80's the Stoddard County Fair Board has awarded over \$56,500 in scholarships to Stoddard County Graduates.

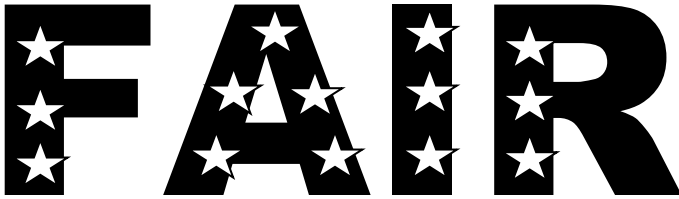
